

NOTICE OF PRESCRIPTION DRUG COVERAGE AND MEDICARE

Important Notice about Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your prescription drug coverage available through Medicare. It also tells you where to find more information to help you make decisions about your prescription drug coverage. You may ask for another copy of this notice from the Arizona Metropolitan Trust (AzMT) at any time. Key points for you to remember:

1. Medicare prescription drug coverage (sometimes called Medicare Part D) is available to everyone with Medicare.
2. The prescription drug coverage offered to you by AzMT is generally better than the standard Medicare prescription drug coverage.
3. If you decide to keep your coverage through AzMT's plan, you do not have to do anything.
4. If you keep your prescription drug coverage through AzMT and then later decide to buy prescription drug coverage through Medicare, you will not have to pay a penalty (that is, pay a higher Medicare premium.)
5. If you have questions about this notice or would like more information about your coverage options, please contact your Personnel Office or Human Resources Department.

For the upcoming year you have several coverage options:

1. You may stay with your current plan offered by AzMT. Because AzMT's coverage is, on average for all plan participants, expected to pay out more than standard Medicare Part D prescription drug coverage will pay, you can keep this coverage and not pay a higher premium (that is, there is no penalty) if you later decide to enroll in a Medicare Part D plan. If you decide to keep your existing coverage through AzMT's plan, you do not have to do anything. You will continue to be enrolled in AzMT's plan and receive the same benefits you currently have.
2. You may enroll in a stand-alone Medicare prescription drug plan to obtain Medicare Part D coverage. All Medicare Prescription drug plans will provide at least a standard level of coverage set by Medicare. Some plans might also offer more coverage for a higher monthly premium.

If you want to enroll in a Medicare prescription drug plan, open enrollment for the Medicare prescription drug plans runs from October 15th through December 31st of each year. Before enrolling in a Medicare prescription drug plan, please contact your Human Resources Department to discuss what health insurance coverage you have through AzMT to avoid duplicate coverage.

You should also know that if you drop or lose your prescription plan with AzMT and don't enroll in a Medicare prescription drug plan or another plan that is at least as good within 63 days after your coverage with AzMT ends, you will pay more (that is, pay a penalty) to enroll in Medicare prescription drug coverage. When you enroll in a Medicare prescription drug plan, your monthly premium will be increased at least 1% for every month you did not have coverage. For example, if you go 19 months without coverage, your premium for a Medicare prescription drug plan will always be at least 19% higher than what most other people pay. You will have to pay this higher premium as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the next October to enroll and until the next January to receive benefits.

3. You may decide not to have any prescription drug coverage from either AzMT's plan or from a Medicare prescription drug plan. If you decide not to have any prescription drug coverage, you will have to pay a higher premium later (that is, pay a penalty), when you decide to enroll in a Medicare prescription drug plan. Later when you enroll in a Medicare prescription drug plan, your monthly premium will be increased at least 1% for every month you did not have coverage. For example, if you go 19 months without coverage, your premium for Medicare prescription drug plan will always be at least 19% higher than what most other people pay. You will have to pay this higher premium as long as you have Medicare prescription drug coverage. In addition, you may have to wait until next October to enroll and until next January to receive benefits.

Keep this notice. If you enroll in a Medicare prescription drug plan in the future, you may need to give a copy of this notice to the plan to show that you are not required to pay a higher monthly premium. You may ask for another copy of this notice from AzMT at any time.
